INTRODUCTION

HEDGECENT is operated by HEDGECENT LTD, a regulated and licensed international CFD broker. HEDGECENT LTD is authorized by the MWALI International Services Authority (Comoros) with license number T2023375 as an international CFD broker. country Registered at PB 1257 Bonovo Street, Fomboni, Comoros, KM.

Eligibility and Participation

- 1.The \$30 Welcome bonus (the "\$30 Welcome bonus" or "Welcome bonus") is organized by Hedgecent ltd. (hereinafter the "Company").
- 2.The promotion is available ONLY to new live account holders of STANDARD Accounts with Hedgecent. Existing Live account holders are not permitted to participate in this promotion.
- 3.Live account holders must be of 18 years of age and/or above.
- 4.To be eligible to receive the \$30 Welcome bonus, the participant must first obtain a new fully approved Live trading account.

Account and bonus conditions

- 1.The amount credited into the Account, by the Company, are in the form of non-withdrawable, nontransferable trading credit (the "Trading credit" or "Credit").
- 2.The Amount credited is valid for a period of 1 month from the date the credit was granted, however,
 - a.If the Account is inactive for 5 days or more during the 1 months validity period, the credited amount will be canceled.
 - b.If the Client submits a withdrawal request, this will automatically result in the cancellation of the Welcome bonus.
- 3.The Client may only withdraw from their Account if profits are equal to or higher than \$30 and provided that closed lots reach 5 lots (Round turn).
- 4.The max amount withdrawal allow is 30\$.
- 5.Once the client requests withdrawals, the remaining balance will be transferred to trading account as credit and it can be used as trading margin.
- 6.Robots (Expert Advisors) are not allowed for this campaign.
- 7.When calculate required trading volume, stock trades and any trades less than 2 mins will not be included.
- 8.In the event that the Account is stopped out, the credit amount will be settled.
